Pam Douglas – Candidates were brought up from Christchurch last year and the NZDJA paid the costs.

Brian Harris – It was an option adopted by the NZDJA Association and has been a practice for a number of years to move candidates to ensure a coverage of the groups they are sitting.

NOTICES OF MOTION:

Notice of Motion No. 1

The NZDJA Board would like to move a Notice of Motion to make the following amendment to Rule 12 of the Constitution.

12.0 JOINING FEES, SUBSCRIPTIONS AND LEVIES

12.1 If any Member does not pay a subscription fee or levy by the date set but the Board or the Board Secretary and this fee or levy remains unpaid the Board Secretary will give written notice that, unless the arrears are for a period of 90 days beyond the due date, the Member's Membership will be terminated. After that date, the member shall (without being released from the obligation to pay any sums that are due to the Association) have no Membership rights and they shall not be entitled to vote at any Meeting or to participate in any Association activity or to carry out any judging assignment. The Board may as its discretion send reminders to the member regarding the overdue amounts.

Rationale

Under the current wording if the Board set a due date for payment, once that date is reached the member is already overdue. However, we currently have to send another written advice and wait a further 90 days before the payment is overdue. This way it is clear that if payment has not been received within 90 days beyond the due date then the membership lapses.

New Credit Activity

To recognise contribution to exhibition at the Judges Practical Examination in the form of Credit Reference Points.

Rational

For some time now the number and also the quality of exhibits entered at the Judges practical Examination have been a concern to both examiners and candidates.

All Branches experience difficulty in getting entries for the exams for a number of reasons,

- Often multiple judges for group increased time at show
- Reporting times are not accurate increased time at show
- Little or no rewards (i.e. no CC's on offer)

• No perceived value – little return for a winters day at examinations.

However we should expect and receive better support from both judges in training and All Breeds Judges.

Whilst the Judges Training Sub-committee is currently working through positive changes to the Practical Examination System, the above proposals go some way towards increasing the entry and soliciting the support of fellow judges immediately.

To undertake an Open Book Examination on Show Regulations, Anatomy, Glossary of Terms when considered necessary by the Board.

Consequences of non-compliance are left up to the National Board.

Rationale:

There are not many judges whom one does not see at any Branch Activity, nor do you see them steward. A judge should remain active and maintain a connection with their Branch.

There are frequently changes to Show Regulations that not everyone is aware of. These could have repercussions in the judging ring. E.g. change of age for reporting non entirety and the use of ramps etc.

PRACTICAL EXAMINATION:

Presentation by Ray Greer

Ray Greer explained the there were three members on is committee, Carole Tippler, Chris Graham and Ray as Chair. A swat analyse was completed and a tyip out session, and 6 weeks ago was when we were able to present our first report to the board. We looked at what has stood the test of time, how we have produced some very good judges and well respected judge, we looked at strong process, our weaknesses in the short term and also long term, we looked at the assessments and the examiner pool. We assessed the quality of the dogs being part of the practical examination, how we can encourage the nerving candidates, and how the practical examination can drift into a verbal critique and the lack of basic training offered at a branch level
